

Got falsely accused of sexual assault/rape. How to proceed? (Part 2)

I was recently falsely accused of rape/attempted rape. Sally (using fake names for obvious reasons) the girl who claimed I tried to rape her told the police the truth and that I did not do anything to her and all we did was make-out.

Bob, the orbiter/white knight who came to Sally's "rescue" is still spreading lies about me around campus claiming that I did indeed rape Sally, which is not true at all. Bob is in a prestigious campus organization and posted into his organizations private group chat (has over 100+ members) claiming that I raped Sally even after Sally explained to Bob (And the police) that I didn't rape her, Bob is still telling people I did.

People are now labeling me a rapist, isolating me, ignoring me, avoiding me, and shunning me. Some of the people in my social circle have started treating me differently. I was also told not to come around Bobs organization, attend any of the organizations public events, or come around anyone that's in he and Sally's social circle (which is made up of influential student leaders on campus). I'm also now being black listed from joining specific campus organizations because people have formed a bias against me and are labeling me a rapist.

Sally and is not confronting Bob about it or clearing up the confusion. I have evidence, timestamps, receipts, call logs, texts, screenshots, video and audio recordings that prove my innocence.

I'm stressing out and I feel like I cannot talk to anyone other than my two friends one of which was at the party and told me to take Sally and the other of which was the first person I called when Sally "disappeared" from my apartment. I'm also finding myself starting to get severely depressed and avoiding places on campus in fear of being ridiculed or ostracized.

Today Bob saw me on campus and stared me down (basically sizing me up) and he smirked. A friend of mine also saw this happen.

People are also exaggerating the story claiming I was aggressive with Sally and would not let her leave my apartment that night and that she said no several times and I continued, all of which is not true/never happened.

I've contacted a lawyer and plan to go to the police station to get official copies of the police report, body camera footage, as well as video footage from my apartment complex.

Is there anything else I should do?

TL;DR- Guy keeps spreading false rumors that I raped/attempted to his female friend, when the girl already admitted I didn't. It's severely affecting my social life, campus involvement, and mental state.

Chances are you wouldn't. For one you'd have to pay out an ass ton for contingency fees (what the lawyer takes when you can't afford an hourly rate, usually 40%). Then you pay taxes on it.

Damages also can't be financially disastrous to the defendant. If Bob's full net worth is 8k, you can't get 8k. There's also a concept called remittitur (a defendant can have jury damages lowered), he can also appeal the initial judgement too.

This is why a huge chunk of civil lawsuits are settled, and also why people tend to sue companies rather than people (companies tend to have "deep pockets", individuals really don't).

Edit: Not saying you shouldn't explore this avenue, you absolutely should. Just don't expect it's anything like what most people "hear about".

I would suggest you even visit the LegalAdvice subreddit, present your situation and ask if there are any lawyers in your area on the sub, and if so, to point you to their website.

First consultations with lawyers are usually free and they will assess your case's viability to you and also to them on whether to pursue or not. Interview several to get a feel for your best options and how they would proceed with your case, what you would need to produce for evidence, especially what your damages are/would be and likely outcomes if you move forward with suing.

Having damages (monetary is best) is the key to your case. Your situation is based on slander, so it goes into civil court, aka the twilight zone of our legal system, instead of criminal court where everything is pretty much cut and dry.

You may get a lawyer willing to go on a contingent basis where they take a percentage (usually 30 - 35%) of the settlement(s).

Per jadeHelm2015's advice/comment, my experience with lawyers (real sharks) is that once they get involved, they will sue everyone involved to maximize effect and leverage the most out of the case.

Think spaghetti thrown at the wall.

I breezed through it but with a slander case there needs to be 1) monetary damages, and 2) intent to defame.

Monetary damages is easy. Timelines usually corroborate lost jobs with events like these fairly well. Proving that the defendant both knew it was false and knowingly spread the lie with intent to harm your reputation is hard. Usually it involves getting access to private communications between people, and I don't know if a judge will grant a warrant to open someone's private texts to a court over a matter like this.

BUT: this is harassment plain and simple. Tell them to stop in some recordable way. A text message is fine. When they continue, go to the sheriffs office and report the harassment, try to record it somehow because that'll be huge. Next you'll ask to file or be advised to file something called an APO, active protection order, or PFA in some states (protection from abuse) but in my experience PFA orders are more for domestic issues. Now; this APO does everything you need it to do. They cannot talk to you, and it can be a requirement of the APO that they not spread these rumors about you. The courts cannot compel speech,

however, and will not be able to force a public retraction, apologies, admittance if wrongdoing or anything like that. They can only prevent further harassment and upgrade the penalty through a writ like the APO.

One of two things or both may result from this, fallout for them and fallout for you. For them it could mean ostracism and hate, or it could backfire on you and now you're the guy who lied to the cops to get an innocent girl in legal trouble. From that there's no real recourse. You can't APO an entire school.. the APO could potentially remove them from school grounds or buildings during your class hours, though I'm not sure if the judge will impose a distance on an APO. But, if they violate the APO they get to enjoy a few nights in jail to think about the hull shit they've caused.
