FR: A parallel universe: County Jail

Tl; dr

All the social dynamics discussed here at TRP are in effect in jail. In 2015 I served 8 months which was the longest 8 months of my life. Overall I am grateful for my experience, but I don't recommend anyone test what they are made of and visit. It's fucking harsh.

Its important you know how much items from canteen cost:

Ramen noodle soups are \$1.25 and double as a \$1 bill in jail.

A regular sized Snickers bar is \$3.

A 20 oz bottle of Coke is \$3.

A big bag of Hot Cheetos is \$7.

A bar of Dove soap is \$5.

Phone calls are \$1.20 for the first minute and 25 cents for each additional minute.

Alphas: These are the dominant men who are usually good looking or physically threatening, but confidence, a ruthless reputation and social savvy trumps everything else. They enjoy endless perks which include getting <u>invited to dinner</u> all the time, having their pick between old and new boxers, socks, t shirts, and bath towels and getting first crack at any magazine pages featuring hot poon. They have dibs on additional plates at dinner or good books introduced to the tiers library.

While everyone gets a faded county jumpsuit, these guys DHV by buying brand new gear through the jails black market. If they don't have the means to buy it from their own pocket, they befriend a beta and "ask" him to buy it.

It is always Alphas who are in positions of power as members of what I call "the council" There are numerous positions to be had: the leader, his right hand man, the guy who delegates clean up, the workout monitor, and the guy that interacts with the correctional officers on behalf of the inmates. These positions are similar to our elected officials, minus the elections.

betas: These guys may be Alphas on the street but this is a whole new world they find themselves in. The stakes are too high to AMOG someone and end up getting their face rearranged (happens twice a week at least). The betas primary power is their money (canteen items). If they are broke, they hopefully know how to draw, make paper mache using newspaper or cut hair with combs and razors; these are all forms of currency.

The unskilled/broke betas are used to carry out undesirable tasks such as unclogging toilets, moving the bunks in preparation of disciplinary beatings and afterwards cleaning up the blood on the floor. On several occasions betas admitted blame to correctional officers for an offence committed by an Alpha.

During casual interaction, betas are the guys on the sidelines providing the laughter and the "and then what happened?" as the Alphas hold court and tell stories. Validation for the beta comes in the form of an Alpha's presence for a few minutes or complimenting them on their "cooking" skills after the Alpha devours a \$8 portion of food in one sitting.

Betas are always the butt of jokes and they don't dare speak up. They agree and amplify, but not in the way we talk about here. They literally play the smiling punching bag and make fun of themselves because they are scared to death of the confrontation, and rightfully so.

Omegas: These guys have thrown in the towel. They do not socialize because either they don't know how

to or the anxiety is literally crippling. The Omegas tend to be head cases taking psych meds, neckbeards or very feminine men. These feminine men were probably betas on the outside but got demoted as soon as the handcuffs were put on.

I'm the man, but my girl doesn't know it.

Although the number one topic of conversation is women, everyone is constantly DHVing about something. Every dimebag dealer was pushing pounds on the outside. Every gangster murdered 5 enemies with his bare hands while every pimp had 5 Kim Kardashian's waiting for him at home. You couldn't believe any of it but it was still entertaining.

The real insight came at the end of the night. Something happened to the inmates after lights out, most ditched the "front" and spoke openly. The majority of what I mention happened was overheard during phone calls in my cell or told by guys after hanging up with their SO. Here these men were at rock bottom, and their women were playing different versions of games red pillers know all too well.

A common occurrence was SO's not picking up calls or forgetting to put money on the phone or in canteen accounts. Some women would cry, profess their love and speak of the void in their life left from their missing men. However, they were failing to get evidence or money to lawyers who could actually make a difference. Often, men who did drugs with their women were told "your homeboy came by yesterday and smoked me out, he says hi," or other similar comments to inflict pain. Ultimatums were all too common and of course the men would agree just so they could have continued contact.

Go Ahead, Laugh at My Pain

Throughout my 8 month stay I was asked one simple question at least a thousand times. "You think she's fucking somebody new?" The answer (not just from me) was always "no shit" followed by laughter.

A common occurrence at night when someone got off the phone was to announce some news his girl had just broke to him, to the whole tier. "Hey guys" they would yell, "my bitch hung up with me cause she had to get ready for the club." Or, "my wife dropped off the divorce papers this morning." even "my girlfriend doesn't think she could wait for me another 3 months." Every single man on that tier would yell in unison "FUCK THAT BITCH!" Loud and without exception. It was tradition throughout the whole jail.

Two characters: Alpha Chris vs beta Frank

Alpha Chris: Chris not only led 40 members on our tier, but the 3 leaders in neighboring tiers reported to him as well. He was a good looking dude with a motor mouth, intelligence, a sense of humor and a dominant personality. What made him an excellent leader however was his credibility. His jokes weren't funny because they were funny, they were funny because they were true. His stories weren't entertaining because we were bored, they were entertaining because you knew it actually happened.

He was a fucking tyrant but operated with such charm you couldn't help but like the guy. To boot, he had a half a dozen bitches that were constantly putting money in his account. He would use a new betas phone time every night to conduct business or just flirt. Many times, betas talking to their SO would give up their phone so Chris would flirt with their girl and have some fun.

One day Chris came back from court after getting handed down a guilty verdict. He would be sentenced to 15 years in one month for gun trafficking and transferred to prison. I expected him to return a shell of a man, instead he came back with a new sense of urgency. He said it was time to make money before he was transferred to prison so he could invest once he got there. Soon our tier was flooded with drugs, tobacco and porn. I had read in books and articles that in America's jails reside inmates that parallel fortune 500 CEO'S in drive and talent. This guy was who they were talking about.

Beta Frank: Frank was a very masculine looking dude standing 5'8" and in good shape, but could not be

mistaken for handsome. He was an active gang member but it was obvious he wasn't the most violent, the best dressed, or the one who made the most money in his gang.

He was in jail because his current LTR had called the cops on him during a drunken scuffle. She was the one who had hit him first and he hit her back, resulting in his second DV charge with the same girl. Frank was one of the nicest most genuine guys I befriended. He had devil horns tattooed on his forehead, and gang tattoos covering the rest of his body, but it was clear he was a "gangsta" and not a gangster.

He told me he didn't fight his case because his girl was raising a toddler from another man and he didn't want the baby to suffer. The woman never once put money into his account while she lived in his home and enjoyed some of his government benefits. One night Frank managed to get her on the phone and was told she would visit the upcoming Sunday. Frank got super excited, indebted himself for a trim of his facial hair and a haircut so he could look fresh to see his woman. All day Sunday Frank was restless waiting to be called to visiting. He was crushed when his name was not of those called for the last round of visits.

A few days later he told us he had gotten into an argument with her for flaking and told her to fuck off. One month later he got 2 photos with a letter in which she apologized. One photo was of her cute 3 year old son, the second was of one of the ugliest and fattest excuses for a human being I had ever seen, trying to look provocative. At the time, I thought she was a decent person for reaching out. Now that I think of how Frank's frame crumbled I know it was a calculated move. Frank was excited and started making plans to buy phone time from someone else to call her. A couple of months before his release he decided to get one of those dick piercings where the stud lays under the skin of the dick head. He was convinced he would win her back once he got out.

Last Thoughts

I met a lot of beta "Frank's" but this guy was the epitome of a beta in need of TRP. About a third of the inmates in jail were there for DV charges. Half of those claimed that it was actually their SO who hit them but they got arrested instead.

The last thing I'll point out is that any inmate charged with a sex crime is considered a "piece of shit" and is on the same level as a snitch. These guys get housed separately (only after they request it) in protective custody because jailhouse custom is to fuck up anyone who is a piece of shit, no questions asked. I can't imagine what some of these guys who end up incarcerated over false rape charges go through.

PSA FOR EVERYONE HERE: Keep in mind guys that the sketchiness of jails varies from county to county and state to state, and not all inmates are as prone to violence at some jails as they are at others.

I had to do a few months for some shit I pulled a while ago and I was at a jail for people who had already been sentenced (punishment of 1.5 years or less) or were going to court for something that could not sentence them to more than a few months. There were like 7 fights in the whole period of time I was there. But the jail I was in right after getting remanded in court? There were people in there facing trial for charges that will get them 5+ years in prison, fights broke out much more often.

You guys want simple, actionable advice if you're ever in jail?

1. Don't disrespect others and don't let others disrespect you.

2. Don't lie.

3. Don't steal.

If you do those three things and aren't retarded in terms of street smarts, I can almost guarantee you that you won't have any problems in jail no matter how long you have to stay.

The only annoying thing is the politics, having to care about race issues is kind of a drag. Again, won't be an issue if you have street smarts. People in jail value being "real" and honest and hate fake people, so just be real with them and don't try to be hard and no one will give you a problem. Most people are honestly just looking to do their time and get out, they generally won't fuck with you if you don't give them a reason to. There will inevitably be people in jail you'll run into that will give you a problem, but your skin color should back you up if they're fucking with you for no reason. Another option is setting up a 1v1 fight. Talking about race brings me to my last piece of advice:

4. If someone who is from your race is getting attacked, you MUST intervene and defend him.

The way races work in jail is the other people with your skin color/designation are your backup if someone randomly attacks you and you are there for them if they are attacked. This is what keeps you in good standing with your race, and it's honestly a pretty fair exchange; you get protection but must also be willing to protect others. Follow #4 and your time will be easier, this I can guarantee.

Not automatic enemies, depends on how serious or violent your jail/prison is, and depends on the race. It's all just prison politics really, and since the guys with the longest rap sheets hold power when they're in jail, prison politics trickle down to jails. BUT, to answer your question, in a lot of jails most people are just coasting and looking to do their time, so no the different races aren't automatic enemies. Each race tries to give each other enough space so there aren't any issues, and this results in most people being "neutral" towards one another I guess you could say.

For example, I was white and I played dice with some of the black people all the time. And the others, too (others are people who don't fit into white, black, norte/sureno, asian, etc. like pacific islanders or puerto ricans and shit). My jail was for people who already had small sentences so people were mostly friendly or at least respectable towards one another. However, one big rule for the whites is you don't accept food from other races and you don't bet/gamble with other races (to avoid a situation where you owe money to another race and your race has to bail you out; no one wants to deal with that). When I was doing my time I did both. Did that make me enemy #1 of my own race? No, our group of whites at that time (under our leader at that moment) didn't care too much about that kind of stuff as long as you weren't an idiot and didn't get yourself into trouble. If it was prison they would've definitely cared though, so again, it depends on where you get locked up.

Edit: To answer your second question, no not really as long as you keep a level head because it's not all out war it's just a system of rules that keeps everyone in line. You just keep that in the back of your head. What did change in me from jail was I became more aggressive in the sense that I was quicker to take an issue from strictly verbal to possibly physical. In jail, the way you defend your reputation is by not letting people disrespect you, so if someone goes up to your table at lunch and takes a piece of bread from you without asking, you have to make an issue out of that. On the outside (real life), 1) that would never happen and 2) no one will "respect you less" for not starting a fight over a piece of bread. Basically after I got out it took a week or two for my mind to get back into the middle class way of life. Different rules in jail than the real world, so you just gotta abide by those rules while you're locked up. On the outside? Your life is yours to live however way you want to.

Depends, if it's in an area like a work environment where guards are present and a fight would just cause problems for everyone then a fight would be postponed until you guys were back in your barracks/wherever you all stayed and lived. If there are no guards around it's up to the person who got disrespected how far they want to take the issue. What also might happen is the leaders of each person's race will chat so that the 1v1 is legitimate and doesn't turn into a riot or they'll

sort it out between themselves and then you and the other person you have an issue with will just talk it out. If you and the other person are in the same race then the leader might try to tell you guys to just let it go or if you guys want to turn it into a 1v1 he'll be like "fuck it alright". It's not too uncommon for people to decide to fight each other if they're in the same race and have an issue with each other. This way they sort out their issue and just get back to normal in a way where both men retain their respect/reputation. The only challenge with fights is that if someone gets a visible marking from a fight (black eye, fat bruise on face, etc.) and they have a job or are in the presence of COs often, COs will notice and make an issue out of it and possibly make everyone else's lives harder in the short term by deciding to go search your whole barracks/section/tier just to make a point that they aren't turning a blind eye. Obviously no one wants their shit searched or to get fucked with in general, so if you're in an area where your job is chill and jail life is pretty easy to just coast and do your time, the leaders of each person in the issue will try to deescalate to save everyone else the problems because two randos' pride/reputation over a piece of bread isn't important compared to what illegal things your race is doing in jail, and keeping all that stuff undercover takes priority over simple fights.

So, sorry to give you this answer again but it kind of depends; usually though it'll be a controlled 1v1 at a later time (first opportunity you guys get to fight without bringing heat to your living area) or the transgressor will be asked to apologize by their race's leader and end the issue that way. That happened to me twice actually, where someone pulled some really minor bullshit on me and I was just in zero-tolerance mode for disrespect because I appreciated not getting fucked with (kind of like a shit test, if someone fucks with you and you don't address it/handle it correctly, the instances you get fucked with will increase due to perceived weakness) so I wanted to make it a fight back at the barracks but the other person apologized and then after a few more days went to the COs and asked to be relocated because no one liked them in their race. There will be a few bad apples in there that no one likes, not even their own race, and if they try to start an issue with you they won't have the support of their race so you can either fight, win, and beat the shit out of him, or pressure him to apologize/move out since he has no back up (back up would make it impossible for you to beat the shit out of him since once he's obviously lost the fight his race will step in if you don't stop).

Yada yada yada you get the point by now I'm sure.

Yeah no worries, there is so much misinformation out there about what jail and prison life is like since there are tons of different types of facilities for different levels of offenders and not are environments all the same so I don't mind spreading the word on what jail life is really like. Watching youtube videos of jail before doing time had me thinking jail was a nonstop hell hole with rampant violence; definitely wasn't the case.

Also, bear in mind my experience is from a few months in one moderately low level jail in one state in the US, so it is by no means representative of all other jails. This applies especially to the finer details like how fights/drama gets handled.

One thing I can say with certainty is that if you follow the four rules I outlined in my previous comment, you're 95% likely to be fine.

Id like to point out that this was county jail and not prison.

Back in the late 90's and early 2000's the correctional officers were under Federal investigation for beating on inmates. People ended up dead. When the feds came in and these assholes were indicted, cameras were setup literally everywhere. By the time I was locked up they were pleasant and polite. What was interesting was that the CO's knew to keep the peace in each dorm/tier they would have to work with us. Numerous times they "looked the other way" while some kind of violent act was carried out.

The Alphas spoke to CO's like any Alpha/Alpha conversation. Sports, pussy, money, light jabs of humor and wit but always respectful. Betas would only speak to a CO when spoken to. Omegas were literally invisible.

I didnt feel institutionalized I was simply in a structured environment where discipline and respect were of utmost importance. We worked out 5 days a week and kept the dorm/tier spotless, both mandatory. Unlike the outside world, consequences were painful and immediate. The rest were either too dumb to change their behavior or too numb to care. Some were happy to be locked up as they got a bed, a roof over their head and 3 meals a day.

Yes, I know I'm not OP, but I've read accounts of various prisons by various inmates, they weren't RP accounts but you could break down A/B dynamics from the people they wrote about, and alphas generally tried to either be on the good side of the guards or were hostile in a way that made the guards wary, rather than retaliatory. Betas were naturally submissive around guards or were hostile in a way that got them attacked. It's a careful game, to see if you can scare them without getting beaten by them. But the more harsh the prison, and the better funded, the more likely guards are to simply attack anyone who they deem hostile, so everyone tries to avoid them or get in their good graces.
