And usually courts defend going against the typical anonymity afforded to those charged with most offences, and naming people accused of e.g. rape and sexual assault on the grounds that it might lead more people to come forward to help the investigation. At least, that's how it works in the UK, with the recently released statement from the CPS (or so similar, can't remember who exactly). Why keep her anonymous, unlike those accused of rape/sexual assault? Who's to say she hasn't done this to other people, and accused them of rape? She might have, protected by anonymity, already sent people unjustly behind bars - only they know her name/who she is - or she may have attempted to falsely convict others of rape in "failed rape convictions" that weren't seen as egregious lies as this. Seems just as potentially likely to have happened, hence a need for publishing her name, as when rape/sexual assault charges are brought - except this is a politically incorrect type of charge that were told almost never happens, because its almost exclusively men that are the victims. Yet, it often happens multiply when people are convicted of lying about rape/sexual assault.

ICANN authorizes the creation of TLDs (top level domains) like .com and .info. And they grant oversight of a given TLD to a registrar. .com and .net are both controlled by a company called Verisign, and hence are priced the same. An individual who wants to buy an unclaimed domain buys it from either Verisign or an authorized registrar (like GoDaddy or NameCheap). Verisign sets a minimum price, but registrars with sales rights

can charge above that, pocketing the difference for their services (eg they charge \$11 and Verisign gets \$7.50 of it, they keep the rest). If you register a domain, you own it for the duration of the registration period, and you have the right to renew it in perpetuity. Because you own it, you can then resell it, and you can charge whatever you want, so valuable names can sell for millions of dollars (like sex.com).

I'm Israeli, and there was no vibe of "Cyprus as a whole is responsible" in news sources. Many of them reported that Ayia Napa's mayor has been attempting for a while to clean up the city, clamping down on the excessive parties and alcohol, and making the town more suitable for family vacations.

I've been to Cyprus multiple times, for vacations, company retreats and on a motorcycle trip when there was still a ferry. I also had Cypriot & Greek friends when I was studying in the US. On the whole, I always felt that Cyprus is almost as British as it is Greek, in the good sense, and much more British than London (a bit like rural England). It's certainly much cleaner than most large English cities (-: People here in Israel understand that beach resorts are beach resorts, and (for example) Goa in India, Ibiza in Spain and several of the Greek Aegean islands have much worse reputations (Mykonos). Ayia Napa is apparently esp. popular with teenagers because Cyprus is very close to Israel (the closest destination by air), and flights are very cheap. Accommodations are much cheaper than in Israel's own resort towns like Eilat, which are extremely expensive (NYC level prices) and family oriented.

People were also very much impressed with the Cypriot Police: Investigation seemed to be quick and thorough, careful of the suspects' rights and maintaining their privacy as minors. Lawyers both for the suspects and the woman praised the police. Most noteworthy was the fact that the police didn't give press interviews, and there were no leaks whatsoever. Israeli police would have spent at least as much time giving self-important interviews as investigating, and there would have been many leaks to journalists.
