Utah Valley University (UVU) is committed to providing a supportive learning environment and fostering safe, healthy relationships among our students. As part of our commitment to these goals, the University has enacted Policy 162 Sexual Misconduct; the University and its community members adhere to this policy and will not tolerate the offenses of harassment, dating violence, domestic violence, sexual assault, and stalking. To educate students, faculty, and staff, UVU provides training on these issues as required by Title IX of the Education Amendments of 1972, the Violence against Women Act (VAWA), the SaVe Act, and the Clery Act.

This training is part of an on-going educational program regarding several topics relevant to college life, including relationship violence, sexuality, drug and alcohol use, and sexual assault, as well as resources for reporting and resolving sexual misconduct/violence. This program is intended to help you learn more about these issues, your responsibilities, your rights, your options, and your important role in preventing this type of conduct to help keep our campus safe.

- 1. Enter your UVUID and password. This will take you to the Everfi training portal.

You may take a break at any time during the course. The system will bookmark your spot so you can return later. The deadline for completing Part 1 of this course is within 14 days of this notice. After an intersession of 30 days, you will receive an email notification to complete Part 2. The deadline for completing Part 2 is within 14 days of that notice.
